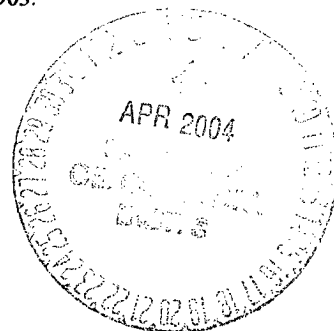
Richardson Operating Company respectfully requests a one (1) year extension of original APD which expired on 2-24-04.
