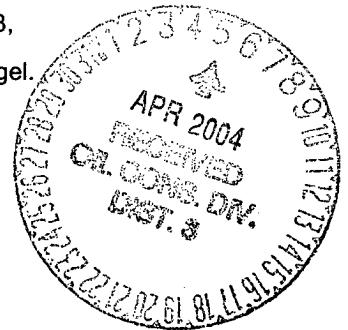

Pressure test casing to 3500#, held. Run GR-CCL-CNL logs. Perforate Fruitland Coal from 709-13, 776-83, 788-92 and 845-53 w/4 spf (total 92 holes). Acidize w/1100 gallons 15% HCL. Frac w/78,000# 20/40 Brady sand; 20,000# 20/40 Resin coated sand; 45,420 gallons AmBor Max 1020 gel.
