Four Star Oil and Gas intends to perforate and fracture the Basin Fruitland and commingle downhole with the Blanco Pictured Cliffs as follows:

MIRU Workover Rig. ND wellhead and NU BOP and pressure test same. Kill well, and POOH with 2 3/8" tubing. Set Bridge Plug at 2050'. Test 5 1/2" casing. If casing test fails evaluate for P&A or repair.

If casing test successful, perforate the Fruitland Coal from 1994'-1908' with two (4) shots per foot adding 152 holes. Fracture treat the formation with 70% foam frac with 46,346 gals of slickwater and 170,000 lbs 16/30 Brady sand.

Flow and clean up well. PU 3 7/8" bit and 2 3/8" tubing. Circulate clean to PBTD at 2050', drill out bridge plug. POOH with tubing. RIH with production string. RIH with pump and 3/4" sucker rods. ND BOP. NU wellhead. RDMO workover rig.

Hook well up to sales and place well on production.
