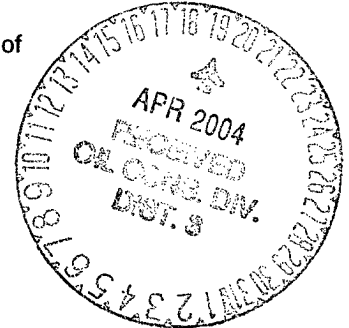

We anticipate bringing this well back to production status in 4th qtr of 2004.
