The original APD did not specify the pipeline route (by Plat) and Richardson has subsequently permitted by the BLM (NMNM109631) a Lateral for gas/water, which will be the Lateral this well will tie into. Forthcoming Arch report by La Plata should cover the pipeline route for this well. All terms of the original APD remain the same.
This well has not been drilled.


