Application for Permit to Drill for the subject well was submitted on 04/02/2001. On 05/27/2001 BP as Amoco Production Company submitted amendments to our Drilling and Completion Program. Amendment to the Drilling Permit were approved on 11/14/2001. Extension was requested to allow for the drilling of the subject well in either the 4th QTR of 2002 year of the 1st QTR of 2003.

The subject well has been placed on our rig schedule and we anticipate that the well should be spud in the latter part of second quarter of 2003. BP, therefore, respectfully request an extension to the drilling permit to allow for the drilling of the subject well.
