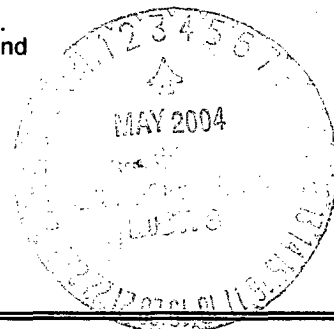

4/6-12-04 Clean out and flow back frac.
4/13/04 Land 2-3/8" production tubing 3099'. RDMO.
