4/13/04 Spud 83/4" surface hole. Drilled to 130'. Ran 3 jts. (121.10') of 7", 23#, J-55, ST&C casing and set at 127' KB. Cemented with 60 sx (71 cu. ft.) of CI "B" with 3% CaCl<sub>2</sub> and 1/4#/sk celloflake. Circulated 4 bbls of good cement to the surface.

4/20/04 Ran 65 jts. (2308.33") of 4 1/2", 11.6#, J-55, ST&C yellowband casing and landed at 2313.33' KB. Insert float is at 2296.03' KB. Cemented with 230sx (474 cu.ft.) of CI "B" 2% SMS cement with 1/4#/sk celloflake and 5#/sk gilsonite, followed by 100 sx (123 cu.ft.) of CI "B" with 1/4#/sk celloflake and 5#/sk gilsonite. Bumped plug to 1400 psi. Float held okay. Circulated 25 bbls of good cement to surface.
