Work commenced to downhole commingle the subject well. Service rig was rigged up and the 2-3/8" production tubing was removed from well, along with the production packer. The well was then cleaned out to PBTD at 8120'. The 2-3/8" production tubing was then run back in well without the packer and landed at 8010'. The well was then turned to sales as a downhole commingled Mesa Verde/Dakota.

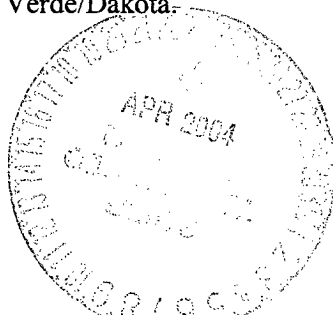
