Pumped 170 sx (205.7 cf - 36.6 bbl slurry) 50/50 STD/POZ, 2% Bentonite, 5#/sx Gilsonite, 3% CaCl<sub>2</sub>, .25#/sx Cello-flake, 0.2% CFR-3. Dropped plug and displaced w/15 bbls FW. Bumped plug to 200 psi @ 0645 hrs. Circ. 10 bbls good cement to surface. WOC. RD Halliburton. NU WH & BOP. PT-OK. PT pipe rams and casing to 300 psi for 3 minutes and 1000 psi for 30 minutes. Good test.
