Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead - 430 sx (1122.3 cf - 199.9 bbl slurry) Class G cement w/3% chemical extender, 0.25#/sx Cellophane flakes, 0.05 g/sx antifoam agent and 0.2% all purpose antifoam. Tail - pumped 100 sx (127 cf - 22.6 bbl slurry) 50/50/G/POZ cement w/2% Bentonite, 2% CaCl₂, 5#/sx Gilsonite, 0.25#/sx cellophane flakes & 0.1% Antifoam. Released wiper plug and displaced w/20 bbls FW & 110.5 bbls slightly polymerized drill water. Bumped plug w/1500 psi @ 1805 hours 5/4/04. Circ. 10 bbls cement to surface. RD Schlumberger. WOC. Changed rams to 4-1/2", NU BOP, set slips and cut off casing. Installed trash cap. RD & released rig @ 2400 hrs 5/4/04. Will show casing PT on next report.
