Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped 150 sx (202.5 cf - 36 bbl slurry) Class G cement w/2% CaCl2 & 1/4#/sx Flocele. Dropped plug & displaced w/15 bbls FW. Bumped plug w/500 psi @ 1730 hrs 4/18/04. Circulated 10 bbls cement to surface. WOC. NU WH & BOP. PT - OK. PT casing and pipe rams to 300 psi - 3 minutes and 1000 psi for 30 minutes. Good test.
