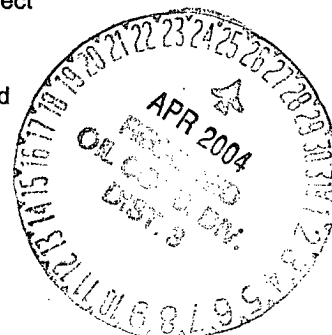

Please reference BLM letter of March 04, 2004, concerning the non-productive status of the subject well. We request to hold the well in a shut-in status pending evaluation of stimulating the Measverde in order to restore production or for possible uphole potential in the Fruitland Coal formation. If testing of the Mesaverde proves unsuccessful we will further evaluate the FC. If review indicates that there is no uphole potential then we will submit recommendation to plug and abandon. We anticipate that within 30 days we should be able to give a definitive answer as to which option we will proceed to take.
