This well was shut in on April 2, 2004, due to the loss of a gas market. A new contract to market the gas from this well is presently being negotiated with Newpoint Gas Resources, L.P. The estimated time that the well will remain shut in is 120 days. Therefore, Mountain States requests approval to leave the Navajo 5-2 shut in until July 31, 2004 awaiting a new gas contract.
