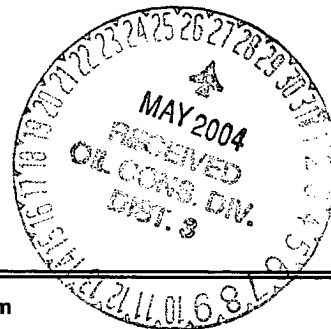

Circulate 5 bbls cement to surface. Circulate between stages. Cement second stage with 475 sks 65/35 Class B poz, 6% gel, 10#/sk gilsonite, 1/2#/sk flocele, 1% CaCl₂, tailed with 100 sks 50/50 Class B poz, 2% gel, 5#/sk gilsonite, 1/4#/sk flocele, 2% CaCl₂ (1063 cu.ft.). Plug down @ 5:15 pm on 05/16/04. Circulated 2 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 1200 psi-ok.
