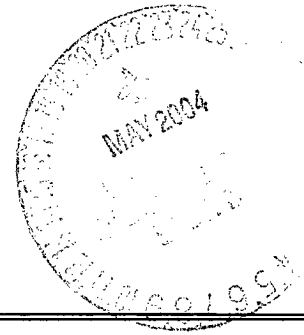

If the workover is unsuccessful, a Sundry proposing to plug & abandon the well will be submitted by the May 31, 2004, deadline. At that time Questar may request a short extension to the May 31, 2004, deadline in order to complete the plugging.
