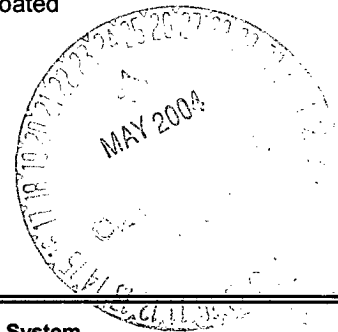

Acidize w/1200 gallons 15% HCL. Frac w/128,000# 20/40 Brady sand; 32,000# Resin coated sand; 61,570 gals AmBor Max 1020 gel.
