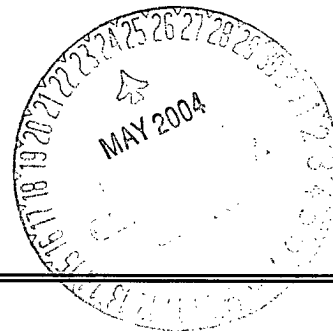

Acidize w/1200 gals 15% HCL. Frac w/46,727 gals AmBor Max 1020 gel, 128,000# 20/40 Brady sand, 32,000# Resin coated sand.
