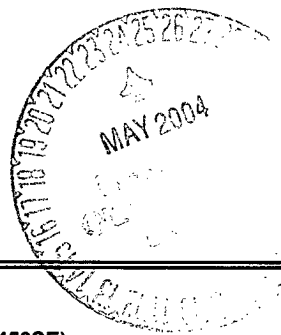

Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead - 390 sx (1017.9 cf - 181.3 bbl slurry) Class G cement w/3% chemical extender, 0.25#/sx Cellophane flake. Tail - Pumped 100 sx (127 cf - 22.6 bbl slurry) 50/50/G/POZ cement w/2% D029, 2% CaCl2, 5#/sx D024, 0.25#/sx D029 7 .1% D046, Released wiper plug and displaced w/20 bbl FW 7 99.5 bbls slightly polymerized drill water. Bumped plug w/1500 psi @ 1220 hrs 5/12/04. Circ. 40 bbls. RD Schlumberger. Changed rams from 7" to 4-1/2". ND BOP, set slips and cut off casing. Installed trash cap.
