We drilled 12 1/4" hole, and ran 8 5/8", 24#, J-55, ST&C Casing, landed @ 176.19 KB (KB=5'0"). Cemented casing with 130 sks Class B Cement w/ 2% CACL2 plus 0.25 lb/sk Celloflake, 15.6#, yield 1.18, 27.3 bbls total cement. We used 3 centralizers on the bottom 3 joints. Circulated 12 bbls of good cement to surface. Wait on cement overnight +/- 18 hours.

On 5/23/04, pressure tested casing to 750 psi for 30 minutes. Held O.K.
