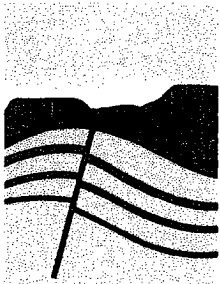

**Yockey Federal #3
Workover Procedure**

1. Dig blow pit, check rig anchors.
2. MIRU pulling unit and air package.
3. Blow down well, ND well head, NU BOPE.
4. Attempt to unset packer and POOH with 2 7/8" (probably IJ) tubing and packer. If packer will not unset, jet cut tubing off above packer and TOH.
5. PU bit and 2 3/8" tubing. TIH. TIH to PBTD or packer depth.
6. TOH.
7. PU casing scraper and round trip to PBTD or packer depth.
8. TIH with packer. Set packer at 1800'.
9. Attempt to pressure test casing to 500 psi.
10. Develop plans to return well to production or P&A based on pressure test.
