**Drilled 6 3/4" hole, and ran 4 1/2", 10.5#, J-55, ST&C Casing, landed @ 2389' KB (KB=5'0").  
Cemented on 5/24/03. Lead cement pumped 181 sks Class B Cement w/ 2% Sodium Measilicate plus 3 lb/sk Gilsonite, plus .25#/sk Celloflake, 12.5#, yield 2.09. Tail with 92 sks Class B Cement, plus 4% gel, plus 3#/sk Gilsonite, plus .25#/sk Celloflake, plus 2% CACL2, 14.5#, yield 1.4. We used centralizers on the bottom 2 joints, and every +/- 400' thereafter. Used 2 turbolators, 1 at the base of the Ojo, and the other in the Ojo. During displacement we lost circulation, and did not get cement returns to surface, will run CBL at a later date. Wait on cement.**
