Lead - 359 sx (765 cf - 136 bbl slurry) Premium Lite FM w/3% CaCl<sub>2</sub>, .25#/sx Floccelle, 5#/sx LCM-1, .40% FL-52, .40% SMS. Tailed w/90 sx (124 cf - 22.1 bbl slurry) Type III cement w/1% CaCl<sub>2</sub>, .25#/sx Celloflake, .20% FL-52. Dropped plug and displaced w/124.3 bbls FW. Bumped plug @ 0715 hrs 6/10/04 w/1700 psi. Circ. 5 bbls cement to surface. RD BJ, ND BOP, NU WH. RD & released rig @ 1315 hrs 6/10/04. The casing PT will be conducted by the completion rig before the completion begins.
