In A follow up to the Sundry Notice dated 7/23/02 and that was approved by the BLM on 7/28/02, A cement bond log was ran and determined that there was good cement at 2810' to 2830' (Menefer formation). A 7" CTBP was set at 3,100'; perforated the Menefer at 2810' to 2830' (10' at 2SPF) on 8/16/02. Acidized with 500 gals. 15% HCl; snubbed and recovered only water - NO oil or gas show.

A Mechanical Integrity Test was then performed successfully on 8/5/02 and was witnessed by AI Yepa of the BLM, CABA, NM Office and by Jimmy Angel, Pride Energy Company's engineering consultant. A New Mexico Oil Conservation Division representative was not available for the witness of the MIT. The well was then temporarily abandoned.
