In a follow up to the Sundry Notice dated 7/23/02 And that was approved by the BLM on 7/28/02, the Menefee was perforated at 2,674'-2680' (2 SPF), Acidized with 500 gals. 15% HCL + Additives; Flushed with 11 bbl. FW 2% KCL. Only produced water - never produced oil or gas. Did not perf 2802-2809. This was done on 8/16/02 through 8/16/02.

A Mechanical Integrity Test was then performed successfully^{on 8/16/02} And was witnessed by Al Yepa of the BLM Cuba, NM Office And by Johnny Angel, Pride Energy Company's engineering consultant. A New Mexico Oil Conservation Division representative was not available for the witness of the MIT. The well was then temporarily abandoned.
