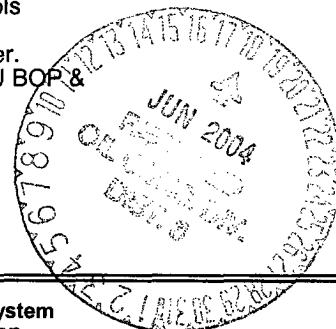

Dropped plug and displaced w/9 bbls water. Plug down @ 0151 hrs 6/4/04. Circ. 10 bbls cement to surface. RD BJ. WOC. NU BH. WOC. NU BOP & choke manifold. PT blind rams and casing to 600 psi for 30 mintues. Good test.
