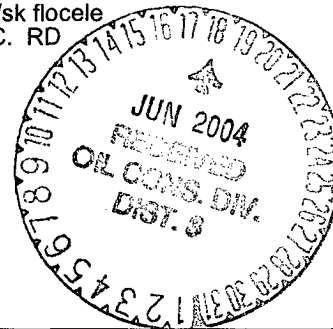

Test casing & BOP to 600 psi-ok.
