05/05/04 Spud well at 2:00pm. Drill 8 3/4" hole to 128'. Run 124' of 7" 20# ST&C csg. Cement as follows: pmp 5bbls preflush. Mix and pmp 50sx Class B cmt w/ 2% CsCl2, 1/4#persk celloflake. Cement yield 1.18cuft/sk, 59cuft, 15.6ppg, 10bbls slurry. Flush with 4bbls water. Circ 4bbls cmt to surface. Shut-in, WOC.
05/06/04 NU BOP. Drill 6 1/4" hole to 838'
05/07/04 Drill 6 1/4" hole to 1348', TD well. Prep to run 4 1/2" csg.
05/08/04 Run 45jts 4 1/2" 10.5# J-55 csg. Land at 1338', GL. Cement as follows: pmp 20bbls water preflush. Lead in with 100sx Class B w/ 2% sodium metasilicate, 1/4#persk celloflake, 3#/sk gilsonite, 12.5ppg, 2.06cuft/sk yield. Tail in with 80sx Class B w/ 1/4#persk celloflake, 3#/sk gilsonite; 15.6ppg, 1.18 cuft/sk yield. Circ 12bbls cmt to surface. WOC.
