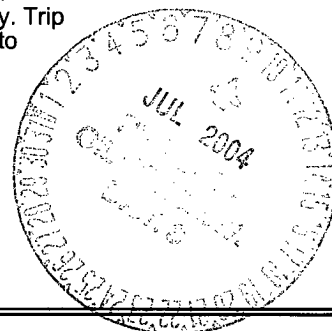

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Move in, rig up completion rig. Pull tubing and packer. Set retrievable bridge plug at approximately 2990 . Test casing and RBP to 500 psi for 30 minutes. Record on chart using 1000# maximum spring and 24-hour maximum chart. Send copy of chart to BLM with subsequent sundry. Trip in hole with packer and tubing. Land as-was with AD packer at 2986 and EOT at 3073 . Return to pressure observation well. Rig down. Move off location.
