6/3/04 MIRU. Spud well. Drill new 8 3/4" hole to 128'. Circulate well clean. TOH with DP/DC and bit. Well bore caved in. TIH, ream hole. TOH, mix mud. TIH, start reaming. Secure rig, SDFN.

6/4/04 Ream hole to 128'. TOH. Attempt to run surface casing, could not. TOH, ream with 10 3/4" reamer to 46'. Mix mud. Secure rig, SDFN.

6/5/04 Ream well to 128' with 10 3/4" reamer. TOH. Attempt to run surface casing, could not. Secure rig, SDFN.

6/6/04 Ream well to 128' with 10 3/4" reamer. TOH.

Run 125' 7" 20# K-55 surface casing, landed at 126' -1 GL.

Cement surface casing with 65 sx Class B cement, with 3% CaCl₂, 1/4#/sk celloflake, 15.60ppg, 1.18 yield. Circulate 4 bbl to surface. Secure rig, SDFN. WOC.
