Production from this well has not reached the original anticipated volume, which we believe is in part due to the original fracture treatment.

We intend to re-fracture this well with 70Q Nitrogen foam frac in 2 stages - 1) perfs 1766'-1979' using 176,000# of 20/40 Brady sand, and 2) perfs 2011'-2141' with 300,000# 20/4/ Brady sand. No new perfs are planned for this formation.

We will use a blow back tank for returns, so no pit will be required. All equipment will be placed on the existing well pad.

We plan to begin work July 21, 2004, due to rig availability.
