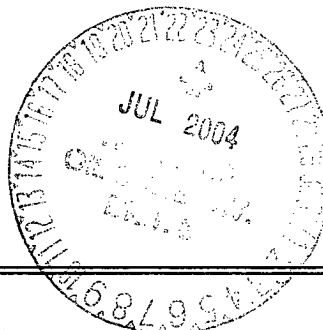

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. We drilled 12 1/4" hole to 180', and ran 8 5/8", 24#, J-55, ST&C Casing, landed @ 175.60' KB (KB=5'0"). Cemented casing on 6/30/04 with 120 sks Class B Cement, plus 2% CACL2 plus 0.25 lb/sk Celloflake, 15.6#, yield 1.18, 141.6 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 11 bbls of good cement to surface. Wait on cement. Shut-down rig for holiday weekend and routine maintenance (7/1-7/4/04). Will resume drilling on 7/5/04.

On 7/6/04, pressure tested casing and BOPs to 750 psi for 30 minutes. Held O.K.
