Cement csg liner: 20 bbls water + 5#/bbl Bentonite, followed by 10 bbls fresh water followed by 30 sx Premium Lite High Strength FM + 2% BWOW KCL + 1/4#/sx celloflake + 3% BWOC Pheno Seal + .3% BWOW CD-32 + .65% BWOC FL-52 (slurry volume 96 cu ft) followed by 211 sx Premium Lite High Strength FM + 1/4#/sx celloflake + 3% BWOC Pheno Seal + 2% BWOW KCL + .3% BWOC CD-32 + .65% BWOC FL-52 (slurry volume 450 cu ft). Bump plug w/1400 psi, held ok. 4 1/2" liner top @ 1988'. Circ out 7 bbls cement.
