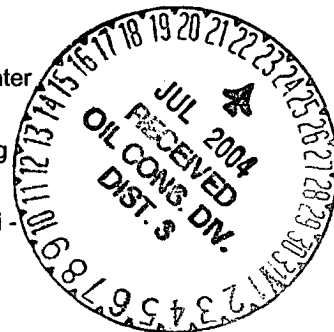

Cement didn't circulate. 6/23/04 Mixed & pumped 6 sx (6.18 cf = 1.1 bbl slurry) Portland Type I-II cement down annulus thru 3/4" PVC to surface. WOC. RD & released rig 6/24/04 @ 1200 hrs.
