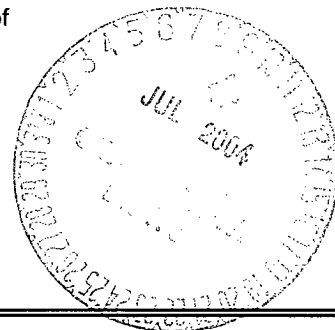

Pressure tested casing at 500 psi for 30 minutes with no leaks. Request long term shut-in of this well. We plan to complete the Fruitland Coal in this well bore. The timing of this completion depends on acquisition of a right-of-way for a pipeline across NAPI lands. We expect completion of the coal and connection to a gas sales line by 7/1/2005.
