Drilled 6 3/4" hole to 2050', and ran 4 1/2", 10.5#, J-55, ST&C Casing, landed @ 2076' KB (KB=5'0"). Cemented on 6/14/04. Lead cement pumped 207 sks 12.5# Class B Cement w/ 2% Sodium Metasilicate, plus 3#/sk Gilsonite, plus 2#/sk PHENOSEAL, plus .25#/sk Celloflake, yield 2.09, volume 433 cu. ft. Tail with 57 sks 14.5# Class B Cement, plus 1% gel, plus 2% CALC, plus 3#/sk Gilsonite, plus .25#/sk Celloflake, yield 1.4, volume 80 cu ft.. We used centralizers on the bottom 2 joints, and every +/- 400' thereafter. Used 2 turbolators, 1 at the base of the Ojo, and the other in the Ojo. Circulated 6 bbls of good cement to surface. Wait on cement +/- 60 hours.
