

Please reference BLM letter of March 04, 2004, and our Sundry NOI of April 07, 2004, indicating our intent to run slick line, tag and flow test the subject with a trailer mounted compressor to determine if it is worth putting the well on compression. Results of the test indicate the well is capable of producing with compression. Compressor has been ordered and we anticipate hook up and restoration to production with in the next 6 months.
