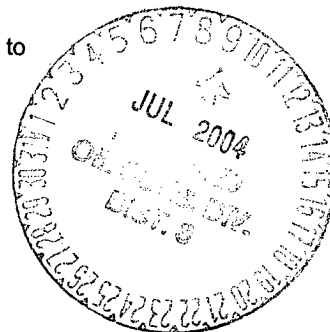

The subject well was being reviewed for possible uphole recompleat into the Fruitland Coal, however, based on the results of the review the well is no longer a candidate for recompleat uphole. BP America intends to connect the well to compression during June 2004 in an attempt to restore the well to production in the Pictured Cliffs. If this proves unsuccessful, a plugging procedure will be submitted for your approval.
