Four Star Oil & Gas Company proposes to modify its previously filed and approved procedure to plug back the Blanco Pictured Cliff South and recompleate to the Basin Fruitland Coal. Instead of plugging the Blanco Pictured Cliff South, Four Star requests permission to commingle downhole the two pools. A bridge plug will be set at 1950 ft and will be drilled out upon completion into the Basin Fruitland Coal. Otherwise the procedure will remain unchanged.

In addition to support the proposed downhole commingling Four Star submits the following:

- i) The NMOCD has previously approved the commingling of the two pools in NMOCD Order #14205
- ii) The two pools to be commingled are the Blanco (Pictured Cliffs) South and the Basin Fruitland (previously issued stipulations.
