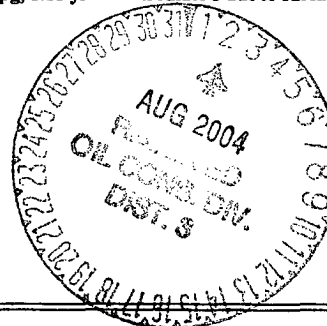

6/12/04 MIRU. Drill 100' of 8 3/4" hole to 130'. TOOH with DP/DC and bit. Run 122' of 7" 20# K-55 surface casing, landed at 123' -1 GL. Cement surface casing with 80 sx Class B cement with 3% CaCl2, 1/4#/sk Celloflake, 15.60ppg, 1.18 yield. Circulate 5 bbl to surface. Secure rig, SDFN. WOC.
