Cement production casing with 75 sx Class B cement with 2% Sodium Metasilicate, 1/4#/sk celloflake, 12.50ppg, 2.06 yield, as lead.
Tail in with 80 sx Class B cement with 1/4#/sk celloflake, 15.60ppg, 1.18 yield.
Circulate 17 bbl to surface.
Bump plug with 1000psi, shut in. WOC.
