Cement surface casing with 60 sx Class B cement with 3% CaCl₂, 1/4#/sk celloflake, 15.60ppg, 1.18 yield. Circulate 5 bbl to surface. WOC. Secure rig, SDFN.

7/14/04 NU BOP, test BOP and surface casing to 600psi, held OK. Drill 766' of new 6 1/4" hole to 839'. Secure rig, SDFN.

~~7/14/04~~ Drill 778' of 6 1/4" hole to 1617'. TD well. Secure rig, SDFN.

~~7/2/04~~ TOH with DC/DP and bit. Run 1597' of 4 1/2" 10.5# J-55 production casing. Land production casing at 1596' +1' GL. 25' shoe joint. Insert float at 1571'. Cement production casing with 115 sx Class B cement with 1/4#/sk celloflake, 3#/sk gilsonite, 12.50ppg, 2.06 yield, as lead. Tail in with 55 sx Class B cement with 1/4#/sk celloflake, 3#/sk gilsonite, 15.60ppg, 1.18 yield. Circulate 20 bbl to surface. Bump plug with 1000psi, shut in. WOC.
