Drilled 12-1/4" hole to 290'. On 6/11/2004, set 6 jts 9-5/8" 32.3# casing at 283'. Cemented casing with 175 sx (37 bbl) Class "B" cement w/ 2% CaCl2 and 1/4# Flocele. Circulated 18 bbls cement to surface. Tested casing to 1500 psi.

Drilled 8-3/4" hole to 3087'. On 6/13/2004 set 70 jts 7" 23# caising at 3066'. Cemented with 500 sx (131 bbls) 50/50 l w/ 3% gel, 5# Gilsonite, 1/4# Flocele, 0.1% CFR-3, 0.4% Halad 344. Tailed in w/ 75 sx (16 bbls) "B" cement w/ 0.4% Halad 344. Circulate 11 bbls cement to surface. Tested casing to 1500 psi.

Drilled 6-1/4" hole to 3470'. Underreamed hole to 9-1/2" from 3073' to 3370'. Utilized natural and air assisted surges to remove near wellbore material. No casing was run or cement pumped in this section of hole. The 2-3/8" production tubing was landed in the openhole at 3422'. If wellbore conditions dictate, we will run 5-1/2" liner in well at a later d
