Drilled 12-1/4" hole to 298'. On 5/27/04, set 6 jts 9-5/8" 32.3# casing at 286'. Cemented with 175 sx (37 bbls) "B" cement w/ 2% CaCl2 and 1/4# Flocele. Circulated 8 bbls cement to surface. Tested casing to 1500 psi.

Drilled 6-1/4" hole to 3670' TVD. On 6/1/04, set 92 jts 4-1/2" 11.6# casing at 3664'. Cemented with 250 sx (65 bbls) 50/50 Poz w/ 2% Gel, 0.2% Versaset, 0.1% Diacel LWL, and foamed with Nitrogen. Tailed in with 380 sx (99 bbls) same slurry without the Nitrogen. Circulated 65 bbls cement to surface. Tested casing to 4500 psi.
