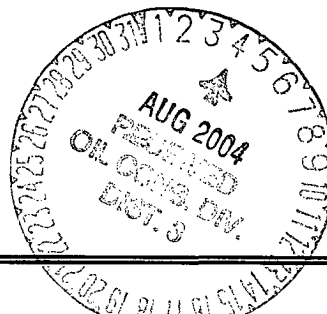

The cement pumped for the intermediate pipe in the subject well was changed from the approved APD.

Due to well conditions, the cement slurry was foamed with Nitrogen to minimize losses during the cement job.

The slurry pumped was a slurry of 500 sx (129 bbls) of 50/50 Poz w/ 2% Gel, 0.2% Versaset, and 0.1% Diacel foamed with Nitrogen. The lead slurry was followed with a tail of 75 sx (19 bbls) of the same slurry with out the Nitrogen. Circulated 25 bbls cement to surface.
