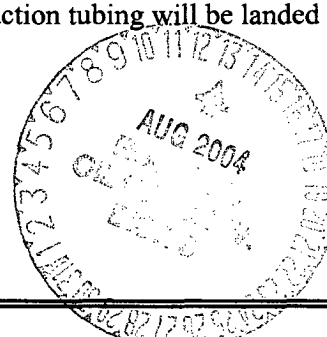

If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths or pertinent markers and sands. Devon Energy proposes to rig up on subject well to recavitate. The 5-1/2" liner will be removed from wellbore. The 7" intermediate casing will be tested to 500 psi. We would like to then drill 100' into the PC formation for a sump. A mud logger will be on location during drilling and logs will be distributed to the BLM. The hole will then be underreamed to 9-1/2" and natural and air assisted surges will be utilized to remove near wellbore material. Pending well conditions, a liner may or may not be run back in well. Production tubing will be landed and the well will be turned to sales.
