Originally proposed to set 4-1/2" production casing @ +1850'.
Request approval to drill 7-1/2" hole and set 5-1/2", 15.5#, J-55, STC casing @ +1,850' with (Lead) approx 150 sx Type III cement w/8% gel, 1/4#/sx cello & 2% Phenoseal mixed at 11.9 ppg, 2.89 cuft/sx followed by (Tail) 80 sx Type III cement w/1% CC, 1/4#/sx cello & 2% Phenoseal mixed at 14.5 ppg, 1.41 cuft/sx.
