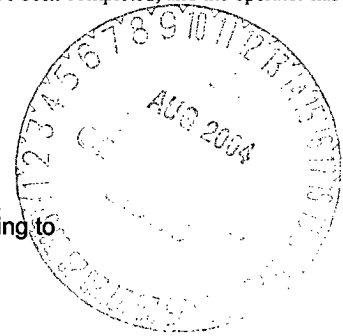

8/4/04 MIRU Aztec #301. Spud 12-1/4" hole @ 1715 hrs 8/4/04. Drilled to 366'. Circ. hole. RIH w/9-5/8" 32.3# H-40 ST&C casing and set @ 365'. RU BJ to cement. Pumped a preflush of 20 bbls water and then Lead - 11 sxs (25.8 cf - 4.6 bbl slurry) Scavenger cement. Tailed w/190 sx (236 cf - 42 bbl slurry) Type III cement w/.25#/sx Cello-flake, 3% CaCl₂. Dropped plug and displaced w/25.5 bls water. Plug down @ 0812 hrs 8/5/04. Circ. 25 bbls cement to surface. RD BJ. NU "B" section & BOP. WOC. PT OK. RIH w/8-3/4" bit. Tagged cement @ 311'. PT pipe rams and manifold and casing to 600 psi for 30 minutes. Good test.
