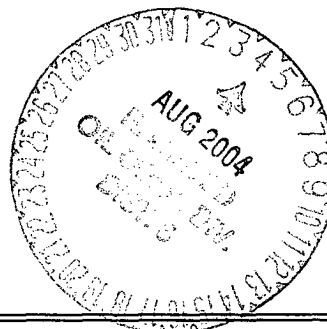

We spud this well on 7/25/04. Due to blow sand on the surface of location, we used a cable tool rig to set 13 3/8" 48# H-40 ST&C conductor casing. Casing is set @ 40' GL or 45' KB (KB = 5'0"). We did find rock @ 37' GL or 42' KB.
