Plug 2) Shot 2 squeeze holes @ 3606'. Set retainer @ 3540'. Pump 50 sks. class B under retainer spot 20 sks. Class B on top of retainer to 3506'. Pressure tested csg. to 500 PSI. Plug 3) Pumped 32 sks. cement from 2152' to 1738'. Plug 4) Spot 20 sks. Class B from 1673 to 1441'. Plug 5) Shot 2 squeeze holes 360'. No injection rate @ 1000PSI. Spot 48 sks. from 410' to surface. Circulated cement to surface.
